##### 1009 Form Revisions:

A public hearing was held on September 27, 2012. A summary report will be sent first to the Oversight Committee, then the final rule will be submitted in November.

##### 1007/1010 Revisions:

A public hearing was held on October 25, 2012. A summary report will be sent first to the Oversight Committee, then, the final rule will be submitted in December.

##### EDI – Companion Guide:

A public hearing was held on November 27, 2012. A summary report will be sent first to the Oversight Committee, then final rule will be submitted in January.

##### CPT Updates :

The proposed rule is presently awaiting approval at the La. Fiscal Office.

##### 1002/AWW Updates:

There will be a public hearing on December 27, 2012.

##### MTS Spine Section Updates:

Changes were suggested at the October 9, 2012 MAC meeting. The proposed rule should be submitted to the Register in December. The updated version is now listed on our website for review.
